A Word From The President

I know we all are looking forward to Spring weather very soon. Our Staff and Board have been very busy over the past several months on many projects and activities. Some highlights include:

✂ Clubhouse restoration due to the water damage is progressing nicely with a few remaining items to complete including new carpet installation. I want to point out that Mark and the Board took this opportunity to make some significant improvements such as new tile in both the Men's and Ladies locker rooms, re-configuration of lockers, a new updated TV and the office area more efficiently designed including protecting our computer server from future water or other damages. Mark and the staff have done a terrific job in overseeing these projects and we believe will they be great improvements to our member's enjoyment when completed. Sally Earnhardt and Jim Meyer have again provided their expertise in working with Mark on selections and their professional advice. Please continue to be patient as we anticipate completion in the next few weeks.

✂ As communicated earlier, our clubhouse roof has been in poor shape for several years and our Board approved replacement in November 2014 with a beautiful metal roof that will match the new clubhouse entrance. Our clubhouse has 2 flat areas on the back (that can't be seen very easily) that require a rubber surface. This rubber surface has to be installed with sustained temperatures above 40 degrees for several days and thus, we anticipate this to be done as step one of the roof replacement the first week of April. Once this is completed, our next step will be the new metal roof.

✂ The golf course irrigation system pump is getting old and requires a significant repair. This repair will cost about \$12,000 - \$15,000 and will sustain the pump for hopefully several more years as the full replacement of the pump is \$100,000. After much discussion and analysis, we believe this is the right move at this time for the club.

Due to balls collecting in a small area with numerous divots the following local rule will apply.

A ball lying in a closely mown area through the green (fairway height or less) may be lifted, without penalty, and cleaned. The ball must be marked before lifted and placed within one club length no nearer the hole. (Rule 25)

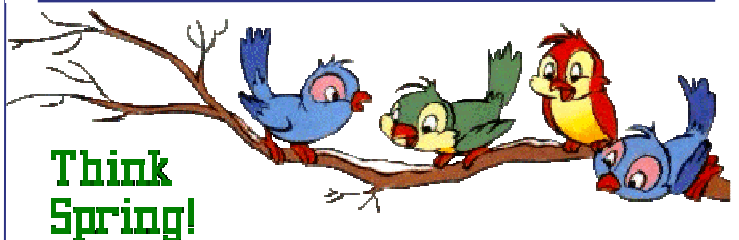

Around the Meadow

Spring is finally here!!! If you have not been on the mountain this winter it has been a tough one. As we approach spring our focus will be on helping the plants recover from the winter. Your staff will be punching greens at the beginning of April. This will help relieve the compaction that Mother Nature has caused during the winter months and promote healthy root growth for the spring and summer months. In addition to aerification your staff will be fertilizing the fairways, tee boxes, and approaches to promote healthy conditions as well as to help the plant grow faster coming out of winter. I hope that all of the members will notice all the tree work that has been done over the winter months. Your staff has cut down several trees on hole 9 that allows for a much better shot selection off of the gold, white, and blue tee box. All of the trees on hole number 5 have been trimmed up and shaped allowing the member now to see the right side of the green from the teeing area that was previously blocked. On hole 10 and 13 the trees have been trimmed near the tee boxes which allows for a larger range of shot selection.

I hope to see all of you on the mountain soon. If you have any questions concerning the course or our approach please feel free to stop me and ask at any time. Once again I look forward to seeing you all on the course very soon.
