**Family Non-Stock Membership** – Members will enjoy unlimited use of the golf course, complimentary practice balls, swimming pool, tennis facilities and access to all social events and activities hosted at the Club. This is a non-stock and non-transferable membership without voting rights.

**Monthly Dues: \$314+ Tax / No initiation fee**

**Individual Non-Stock Membership** – This membership is for one person ONLY. Enjoy unlimited use of the golf course, complimentary practice balls, swimming pool, tennis facilities and access to all social events and activities hosted at the Club. This is a one-person non-stock and non-transferable membership without voting rights.

**Monthly Dues: \$235.50+ Tax / No initiation fee**

**Associate Non-Stock Family Membership** – Members between the **ages of 21 to 40** enjoy unlimited use of the golf course, complimentary practice balls, swimming pool, tennis facilities and access to all social events and activities hosted at the Club. This is a non-stock and non-transferable membership without voting rights. The Associate Member will pay an **annual fee of \$100 on each anniversary** date to be credited toward the Family Stock upgrade at age 41 or before, should a stock be available.

**Monthly Dues: \$235.50+ Tax / No initiation fee**

**Social Membership** – *(Non-Golfing, Non-Stock, Non-Transferable Membership)*  
Enjoy unlimited dining privileges and access to all of the social events. No initiation fee.

**Basic Dining Social Dues: \$70 + Tax per month**

**Basic Dining & Tennis Dues: 105 + Tax per month**

**Basic Social & Swimming: \$175 + Tax per month Jun-Aug / \$70 per month Sep-May**

**Golden Stock Dues: \$214+ Tax (80 years of age & member for 20 years)**

**Senior Non-Stock Dues: \$157+Tax (grandfathered membership)**
