# CENTRAL PARK TENNIS VISITOR POLICIES

#### Guest Agreement (submitted by Team Captain)

If you are not a member of the Central Park Tennis Club (the "Club"), You may make permitted uses of the Club if and only if You agree to the terms of this Guest Agreement. "You" means yourself if you are 18 or over, and yourself plus any children under 18 for whom You are parent or legal guardian. After You agree, this Guest Agreement will be kept on file, and will govern all future uses of the Club by You.

### Washington State Healthy Re-Opening Plan

MASKS ARE REQUIRED AT ALL TIMES, and MAY BE REMOVED ONCE YOU HAVE ARRIVED TO YOUR COURT FOR MATCH PLAY.FOR THOSE THAT ARE FULLY VACCINATED MEANING PEOPLE WHO ARE TWO WEEKS REMOVED FROM THEIR SECOND SHOT OF PFIZER OR MODERNA, OR THE ONE-SHOT JOHNSON & JOHNSON VACCINE, YOU DO NOT NEED TO MASK UP.

#### Waiver and Hold Harmless

You acknowledge that use of the Club involves certain risks, including without limitation injury and disease contagion (e.g., COVID-19). You voluntarily agree to assume all risks and hazards arising out of use of the Club, and You hereby forever release and waive Your right to bring any claim or suit for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence, against, or seek damages, whether known or unknown, foreseen or unforeseen from, the Club, its members, employees, agents, and other representatives, arising out of or in any way connected with use of the Club. You agree that the law of the State of Washington will apply to this Guest Agreement.

## **General Guidelines for Visiting**

All guests and spectators must strictly follow Club rules and Washington State mandated guidelines.

Guest Fees: Teams must have pre-paid their fees and submitted their roster prior to arrival at CPTC.

#### CPTC must be notified 24 hours in advance of any court(s) being defaulted.

Check-In: It is mandatory that all players and guests check in at the Desk prior to advancing to the Courts.

Warm Up Courts are only available on a walk on basis. Guest(s) must check in with CPTC front desk staff to see if a court is available.

Court Allocations: Court allocations are 90-minutes. Players may not enter a court until the previous reservation has departed.

**Overflow Courts** are only available on a walk on basis, unless pre-arranged with the Club. Each **CPTC Captain** is notified of available overflow courts and will manage the allocations with the front desk.

Spectators / Parents - Spectators are allowed, subject to state mandated guidelines and social distancing requirements.

On Court Water dispensers – each court has touch free water dispensers. Touchless bottle fillers are available throughout the clubhouse.

Clothing: Guests must wear non-marking tennis-specific shoes. Clothing and warm-ups are to be appropriate for tennis.

**Socializing:** If teams would like to socialize, the Central Park front desk sells snacks and beverages. Teams are encouraged to socialize in the upper Club lounge area(s) to avoid disruption to players on the courts. Outside alcohol is not permitted. There will be no socializing in the Club parking lot or vacant gravel lot.

TENNIS ETIQUETTE: Proper tennis etiquette and sportsmanship shall prevail. - Penalties at the Club Manager's discretion

- 1. Disorderly conduct will not be tolerated, and offenders will be asked to leave the premise immediately.
- 2. Players shall not enter a court area or walk behind a court while a point is in progress.
- 3. A wall is not to be used as a backboard if the adjacent court is being used for play, as the noise is distracting to other players.
- 4. Non-tennis playing adults and children must not be in the court area unless able to sit quietly and be non-disruptive to adjacent courts for the entire playing period.
- 5. No food or beverage is allowed on the courts, unless it is a dietary needed supplement, i.e., protein or low sugar need.
- 6. Cellular phones and virtual communication must be muted and use limited.
- 7. Team captains are responsible for their players' behavior.
- 8. Proper consideration should be given to on court equipment. Ask for permission before taking shared items from their court, such as ball hoppers, practice balls, ball sweepers, ball machines or any other practice equipment.
- 9. Upon termination of play, the court area must be cleaned of all disposable items, especially cups of liquids. Tennis balls must be placed in the appropriate receptacles (for practice balls or for recycling). Opened ball cans should be placed in recycling bins.
- 10. Players must vacate a court promptly when their court session is over.
- 11. Foul language, loud noises, racket or ball abuse will not be tolerated.
- 12. Facility abuse will not be tolerated and an offending player will be charged with the cost of repairs due to such behavior.
- 13. Members are encouraged to familiarize themselves with THE CODE, The Player's Guide for Un-officiated Matches found in THE USTA HANDBOOK of TENNIS RULES and REGULATIONS. A handout of THE CODE is available at the Desk.
