- Annual Membership Program is valid for the 2015 Golf Season only. Course opening and closing dates will be determined by Ruffled Feathers Management.
- Tee times for full and corporate Members may be made 14 days in advance. Cancellations must be made no less than 24 hours in advance.
- All Annual Members must provide a valid credit card at the time of purchasing. This credit card will be used to guarantee any and all tee times booked for the 2015 season. Any no-show players without 24 hour notice will cause the credit card to be charged for the full foursome guest rate.
- Ruffled Feathers Golf Club is not responsible for any individual's personal property.
- All Annual Members must provide an email address at time of purchase.
- Payment for guest fees, merchandise and Food & Beverage items must be paid for at the time of purchase.
- All players must be checked in by the Golf Shop prior to play. A valid tee time receipt must be presented to the Starter prior to teeing off.
- Maximum of 2 golf carts per foursome allocated to each tee time.
- A Member's privileges may be revoked and the rights of any person or persons entitled to privileges may be terminated for any of the above and following reasons:
  - Commission of any felony or misdemeanor theft at the Club.
  - Willful destruction of the Club, staff or customer property.
  - Physical or verbal abuse of staff or customers.
  - Violations of any Rules or Policies.
  - Conduct which seriously detracts from Management's absolute right to manage the Club and preserve its financial integrity.
