NEW COUNTRY CLUB FORMED

Broadmoor Organization to Construct

Golf Course on Tract in

Fox Woods:

Announcement that an eighteen-hole golf course, with a clubhouse, tennis courts and a children's playground, will be constructed in Fox woods; a 160-acre tract at Fifty-fourth street and Crooked creek, was made yesterday by officers of the Broadmoor Country Club, which has filed articles with the secretary of state showing capitalization of \$200,000 and a charter membership of 125. Albert M. Rosenthal is president of the club.

Executive officers, in addition to Mr. Rosenthal, are Samuel E. Raub, vice

president and chairman of the building committee; Charles B. Sommers, vice president and chairman of the finance committee; Harry A. Kahn, chairman of the grounds committee; Sol S. Kiser, treasurer, and Jesse J. Mossler, secretary. The foregoing constitute the board of directors with A. L. Block, Louis J. Borinstein, Philip P. Efroymsen, Albert S. Goldstein, I. Ferd Kahn, Henry Kahn, David Lurvey, and Sol Schloss and Milton N. Simons.

South of Fifty-Fourth Street.

The ground lies on the south side of Fifty-fourth street, extending from Riverside road on the east to Cooper avenue on the west. The frontage on Riverside road and Cooper avenue is a quarter of a mile, and three-quarters of a mile on Fifty-fourth street. Development of the golf course will be started at once, Mr. Rosenthal said. Plans for the clubhouse are already under way.
