BUSINESS / CORPORATE MEMBERSHIP

Guests play for cart fees when accompanied by an individual on a corporate membership account. The joining membership entity must be licensed to operate in the State of Maryland. Handicap fees (\$40 annually) may apply.

Up to four individuals can be accepted under each Business/Corporate Membership.

Sponsoring Members must sign as sponsors at the time the New Member's application is received by management. Members may sponsor unlimited new Members. No retroactive sponsorships or discounts apply. Other restrictions may apply. See page 4 for definitions of new Members.

****Walden Resident Discount****

All Walden Resident's will receive a 5% discount off their yearly membership dues.

Pool and Tennis Upgrade (New for 2017)

Eligible members may opt to add the Pool and Tennis Upgrade for an additional fee of \$300. This upgrade is subject to availability as space is limited.

Services and Benefits

Members providing appropriate credentials may be approved for club charge accounts (see terms).

All NEW Walden Country Club Memberships are from the join date until the last day of February the following calendar year. Unless otherwise specified by Walden Country Club Management, all Platinum, Gold and Silver Memberships will automatically renew for the next 12 month period beginning on March 1st under the same terms and conditions outlined herein-- including all adjustments and revisions that have been applied by the Club up to that point--and with the addition of any new revisions and adjustments for the upcoming contract period. Notification of upcoming revisions and adjustments affecting annual rates will be mailed or emailed to all Members by February 1st. Members opting out of the automatic renewal process must notify Club Management in writing before March 1st, or the 12 month contract is automatically renewed and will include the revisions and adjustments specified by the Club. Members who opt-out but later wish to re-join are responsible for any fees that would have been assessed in the previous 12 month period had the Membership been renewed on March 1st, or they must wait the full 12 month period and re-join as a new member.

Resignations will not be valid during the contract year unless for qualifying medical reasons as approved in advance by Club Management. Resignations cannot be approved until all Contracts are fulfilled and all monies owed to Walden Country Club have been paid in full by the resigning Member. Except as provided in this contract, no agreement can be terminated by any party other than Ownership and a signed statement from Ownership will be required before any Membership is considered resigned prior to the annual opt-out period.

A "newly joining member" is a member nominee who has not been a member of Walden Country Club in any membership category during the immediately preceding 12 month period. "Family" includes only spouse, unmarried children younger than 21 living at home, undergraduate full time college students under 26, and other IRS qualified dependants living in the residence. All previous "grandfathered" rates are null and void beyond the above provisions, or those proscribed at the discretion of Club Management.

In all cases, any increase in unlimited use golf fees, daily use cart fees or Cart Membership Programs, green or guest fees, and/or all other charges and fees are subject to increase without advance notice, except 12-month pricing programs for currently contracted Members which are adjusted annually as described above and are subject to possible fuel surcharges for cart usage . All increases in prices automatically become the new Club fees for any Club Services and are automatically due and payable by the Members on the date of increase, with new prorated amounts due applying to all monthly payment plans.

All Membership Fees are due and payable up front when joining, including any other fees which may apply. Any monthly payment plans agreed to by Walden Country Club are only for the convenience of **and courtesy to the Member**. A payment plan does not reduce the Member's obligation and responsibility to pay the full membership fees, golf fees, Food and Beverage minimums, upgrade fees, handicap fees, and all other fees in full to Walden Country Club regardless of the level of use or duration of Membership throughout the contracted period. All Walden Country Club Memberships that have charging privileges or a payment program must provide Walden Country Club with a Club approved valid credit card and written authorization of/by the Member for debit charge posting to the member's credit card account by Walden Country Club for payment to Walden Country Club from the Member's credit card account to Walden Country Club for all monies owed to Walden Country Club by the Member's previous and current Membership Agreements & Authorization contract, if the Member's account is 30 days or more past due or if Member voluntarily leaves the Club. Any change in Management or Ownership does not absolve the Member from these financial obligations.

A Ladies or Men's Walden Golf Association annual fee may be required for participation in member organized tournaments. There may be occasional outings or events on the golf course and/or in the building and grounds anytime in cases where Management feels the event is an overall benefit to the Club. All Members are subject to Pool, Tennis and Club rules as well as local laws.

All Memberships can be upgraded during the Membership Year, but can only be downgraded during the opt-out period as announced by the Club. Memberships cannot be transferred.

A Walden Country Club Membership does not constitute any ownership rights for the Member in Walden Country Club and does not constitute any fiduciary interests in Walden Country Club or as sometimes known, Walden Golf Club.
