Conditions of Entry

The application included on the reverse side hereof is subject to acceptance by the PNW Section, PGA of America, and applicant agrees that in the event of its acceptance, it may be rejected or revoked at any time thereafter. To be accepted, entries must be signed, paid, and received at Lake Padden Golf Course. Therefore, players submitting entries are encouraged to allow ample time for delay or error in transmission of their entries.

Both the said Application and Applicant's participation in the aforesaid Amateur Championship (hereafter referred to as the "Amateur") are subject to all Rules, Regulations, provisions of the Constitution and By-Laws of the Pacific Northwest Section, PGA of America and other conditions applicable to the Amateur, as well as to the terms and conditions of the agreement between the PNW Section, PGA of American and the Amateur sponsor(s) with respect to same.

NON-METAL SPIKE RELEASE: It is the requirement of Lake Padden Golf Course that all individuals using the golf course wear spike less/non-metal golf shoes. This requirement is a policy of Lake Padden Golf Course and is not a policy of the Pacific Northwest Section of the PGA of America ("Section"). The use of spike less/non-metal golf shoes may result in the participant slipping on wet or damp surfaces (inclusive of but not necessarily limited to turf area, wooden areas such as bridges and pathways, etc.) and reduces traction on non-level areas of the golf course. As evidenced by the participant's signature on the form of this entry, the participant acknowledges that potential dangers relative to the use of spike less/non-metal golf shoes have been disclosed to participant and participant agrees to assume the risk of sustaining injury arising from or attributable to the use of spike less/non-metal golf shoes at Lake Padden Golf Course's premises. The participant here releases Lake Padden, LLC, members, employees, successors and assigns (the "Indemnified Parties") from any and all claims for loss damage, inclusive of but not limited to personal injury, whether or not caused by participant's use of spike less/non-metal golf shoes at the Lake Padden Golf Course's premises in connection with the tournament. The consideration for this release is the permission granted by Section to the participant to participate in the golf tournament. This release bind not only the participant, but also the participant's spouse, heirs, legal representatives and assigns. By this application, an applicant consents to references to him and pictures of him and his play in publicity, radio and television broadcasting and other exhibition or publication, including their use in any commercial matter.

CARTS/CADDIES: Cart fees are \$15.00 per rider and must be paid to the golf shop at the time of rental. A player may furnish his/her own caddie.
