Outside Event Regulations

Deposit required at time of reservation in the amount of ten (10) green fees.

Payment for entire group must be paid by one person, in one transaction.

Refunds will be issued only if golf course is closed by Superintendent. Please be ready to play
in all weather conditions.

Changes to the number of players must be confirmed within 72 hours of the day of event.

Lake Padden Golf Course wants all tournament events to be a great experience.

- Lake Padden Golf Course's Pace of Play Rules are in effect. Our Player Assistant's will be on the course to help monitor and ensure this rule.
 - Course Rules listed on scorecards must be obeyed. Rules are also posted online.
 - **Coolers are not permitted on the golf course.**
 - **Children under 10 years old are not permitted on the golf course.**
 - A player must be 12 years old unless authorized by a Lake Padden Golf Course professional staff member to participate in any event.
 - Outside food is not permitted.
 - **Punch cards are not permitted.**
- Groups are asked to provide a list of players and their tee times the day prior to event.
 - Our aerification takes place in the Spring and late Summer. Please take this into consideration when planning your event.
- Food: We need to properly staff our restaurant if your group wants to eat. 72 hours notification is required to ensure we can serve each customer in a timely manner.
- **State Law prohibits consumption of alcoholic beverages not purchased at Lake Padden Golf Course.**

Release

User releases Lake Padden, LLC, its officers, agents and employees from any and all liability for injuries and damages incurred to user or user's property while at Lake Padden Golf Course except for any injury or damage directly due to the negligence of Lake Padden, LLC, its officers, agents or employees.

Indemnification

User agrees to indemnify and hold harmless Lake Padden, LLC, its officers, agents and employees from any damage that user may cause, whether intentional or accidental, to the person or property of another while at Lake Padden Golf Course participating in the activities outlined in this Agreement. In the event Lake Padden, LLC, is forced to file suit to enforce its rights under this Indemnification Agreement, User shall be responsible for all attorney fees and costs incurred by Lake Padden, LLC in that action. Further, User shall be responsible for all attorney fees and costs Lake Padden, LLC incurs in defending itself in a lawsuit from which Lake Padden should have been indemnified and held harmless by User.
