2nd Assistant Golf Course Superintendent

Overview

Omaha, NE

Field Club of Omaha was established in 1900 and is one of the oldest courses west of the Mississippi River. Field Club provides over 900 member families and their guests with superior services, programs, and staff. Of the total membership, approximately 365 are full golf members, 450 are Social Members with limited golf access, and 75 Clubhouse Members with limited golf access.

The Club averages approximately 23,000 rounds per year. The Golf Course Maintenance Team utilizes Toro Irrigation Controls and has a mixed fleet of Toro, John Deere, Jacobsen, and Cushman maintenance equipment.

The Club has a supportive and active membership with many families having enjoyed membership for generations. The Club has had year-over-year growth across all membership categories for 7 consecutive years until 2020 when the Club reached full membership. There are many reasons for this success, chief of which include the revitalization of the midtown Omaha area and increased club-wide programming. The membership enjoys a 5200-yard par 67 golf course, with tree-lined fairways and small target greens. The Club is active throughout the year and hosts a full calendar of activities and events in all areas, with a high emphasis on family activity.

In June 2022, the Membership overwhelmingly approved the implementation of a monthly Capital Dues Program to create a consistent and reliable source of capital funding to refresh the Club's three main amenities; Golf Course, Pool Facility, and Clubhouse. The Board has consistently invested in the facility with \$6 million in improvements completed over the last decade. Also in 2022, the Board approved an \$11 million renovation of the Club's three main amenities which is in process and scheduled for completion in late 2024.

• The first phase of the latest version of a golf course master plan started in Fall 2021 and was recently completed in the Fall of 2022. This included two new green complexes, several new and renovated bunker complexes, five new tee complexes, expanded practice facilities, and drainage, irrigation, and cart path improvements.

- The Pool complex had initial improvements made to the deck area in Spring 2022 with a full renovation of both pools completed during Winter/Spring 2023 and opened Memorial Day 2023.
- The Clubhouse renovation is set to start in Fall 2023 and take approximately nine months to complete. Included in this renovation will be a 3,500 sq. ft. addition housing three state-of-the-art golf and activity simulators located near the renovated golf shop. A new family-centric sports bar is also included along with a 50-seat pub adjoining the simulator facility. Once complete, the Club will move from a single outlet dining facility hosting 100 members and guests to three dining outlets capable of hosting 350 members and guests.
