

Virginia Tech Fundraiser Nets over \$50K Fourth Year in a Row



The VGCSA Board and their VTC partners are pleased to announce the results of the 2020 Virginia Tech Turfgrass Research Classic, held on August 31st at Independence Golf Club. For the fourth consecutive year, the tournament raised over \$50,000! The final amount is \$55,263.03. During the year, \$10,000 went directly to supported current research, including Dr. McCall's project and the 2nd Edition of the BMP Manual.

A check for \$45,263.03 to the Virginia Turfgrass Foundation will support turfgrass research in Virginia.

This tremendous success took a huge effort by the Tournament Committee - a debt of thanks to all of them. Sponsors remained steadfast in their support, including Hokie Patrons Harrell's and Landscape Supply (\$5K each) and BASF and Virginia Green (\$4K

Next year's event is planned for Monday, May 17, 2021 at Independence Golf Club. The Field Day will feature research trials on the club's Short Course. Details are being finalized for the event.

Mauldin Recognized for Environmental Stewardship



Scott Mauldin, CGCS of Powhatan and The Foundry Golf Club has been recognized by the VGCSA as winner of the 2020 VGCSA Environmental Stewardship Award. The award is presented "in recognition of distinguished and meritorious service in the environmental stewardship of Virginia golf courses, and in grateful appreciation for unselfishly promoting the profession of golf course management, which led to the advancement of the association."

Mauldin's first introduction to golf came growing up in Charlotte, NC, when his grandfather would take him out to the golf course. Like many high school students, he had no idea what college he wanted to attend. Then he heard that NC State had started a turf program, and that was a way to work on a golf course. Prior to college, his first golf job was at a municipal course, Charles T. Myers in Charlotte – he earned tickets to play golf. This allowed him to see behind the scenes, before entering State. His first job in turf was as a summer intern at Myers Park Country Club during their renovation around 1991. There he worked on spraying and irrigation, then it was back to school. After graduation, his first job was as a spray tech at Carmel Country Club. Then the City of Concord was building a course, Rocky River Golf Club. He learned a lot working with Peter DeJak followed by Bland Cooper (now a PGA Tour agronomist) – he was there 6-7 years.

His next opportunity was at Jacksonville Country Club on the NC coast. He continued to enhance the property for 7 years, then he was ready for a move. PGA member Jason Baile helped recruit him to The Foundry in 2007. The Foundry was doing a complete renovation, including irrigation. During construction, he thought of getting the Audubon Cooperative Sanctuary designation, which was difficult. It was 2010 when they started planning for Audubon and it took a year to get it. It involves a comprehensive course assessment in various disciplines. The process allowed reduced chemicals, reduced water and improving water management overall. They grew native areas and limited the footprint of mowers. They have been recertified three times since. His philosophy is to keep the course natural - very natural and flowing.

Wildlife abounds at The Foundry. You will see heron, bears, coyotes, and birds (bluebirds, finch, hawks, and bald eagles), deer, turkey and ducks. There are plenty of foxes, including a



family that tried to make a den in a putting green.

Mauldin manages buffer zones on Fine Creek and other streams and ponds on the property. They just got a new Rain Bird irrigation system, which allows them to manage each individual head. This saves water, it's the wave of future, with more precise controls. It was designed by Paul Roche, with all controls on your cell phone. Mauldin also uses various moisture meters for managing water throughout the property. Another innovation is buried soil sensors by Spiio, Inc., which sends data to your phone.

When asked about environmental stewardship by superintendents, he said, "We do it every day, so it's geared into our minds. For instance, draining water to a flat plain instead of diverting it to a creek or spot spraying to reduce the use of chemicals. It's what we do!"

Mauldin feels lucky to work for a club president who is not a micro-manager, Billy Stinson. The club strives for "understated elegance" according to Mike Barr, one of the founders of the club with 310 members.

"To sum it up," he said, "every year I strive to keep balance with family and work, stay educated, and to keep having fun and stay on top."

His family includes wife Tina, his High School sweetheart, and daughters Madison (18) who is at East Carolina University, and Sam (16), who attends Monacan HS. And you can't forget Cooper, the bulldog.

Eagle Recognized for Distinguished Service



Ed Eagle, CGCS of Staunton, VA has been recognized by the VGCSA with its Distinguished Service Award for 2020. The award is "presented to a member who has given his time unselfishly in promoting golf course management and unification of the Virginia Golf Course Superintendents." By all accounts, Eagle earned the distinction through his professionalism and integrity, and his interaction with his fellow superintendents, as well as his leadership in numerous initiatives.

Ed's first exposure to golf came when he was 12 - his family moved across town in Staunton and they were redoing Gypsy Hill Golf Course nearby. Ed met the golf pro, and when he got a little older he was helping on the course -raking bunkers, cleaning carts, acting as starter, a little bit of everything. The pro would let him play golf, and this grew into a part-time job working on the golf course when he was 17. He started as a laborer and left as Department Manager after 17 years.

He did not follow the traditional education path - initially he was self-taught. A Gypsy Hill member suggested he buy turf books and study in the winter and do research. He could apply what he learned on the golf course the next summer. So that's what he did, as well as learning from Harold Harlow, the superintendent. While at Gypsy Hill, Ed got his BA at Mary Baldwin University. Then he went to grad school at the University of Pittsburgh and received an MBA in 1993. He was working at Gypsy Hill GC during that time to get the degree. In 2001 Ed received his CGCS status.

After graduate school, Ed went back into golf and landed a job at Ingleside, where he spent 26 years there as superintendent. His primary mentor was golf pro NL Deaver. Anytime Ed had questions about anything, Deaver would take the time to help him with anything from a golf lesson, to golf course management, to questions about life. Ed became a good player but never pursued competition.

His volunteer leadership began when Dr. Jack McClenahan invited him to an SVTA meeting in the 1990s. He kept showing up, and they asked him to be on the board. Around 1998, Ed went in as Vice President and did two years, then became President for two years, then served two years as past president.



Ed was on the VGCSA board and SVTA board simultaneously in 2001-2002. It was a unique experience because VGCSA was new, having formed in 1999. The board was incredibly involved, and each person had to lead numerous working committees. It was a great opportunity to learn, meet new people and serve the industry. Ed came back to the board during 2008-2009 board and served until his father got sick. Later he returned and continues his service today.

While on the VGCSA Board, projects that stand out to Ed are the BMP Manual and Nutrient Management Planning. Another important initiative was in 2002, when the board went through the water management plan and had to work with the state agencies during a major drought.

Ed believes the VGCSA is in a much better position than in years past, having a management team which allows Ed and fellow board members to focus on the big picture, the members and their golf courses.

Upon hearing about his award, Ed remarked, "I was overwhelmed that my peers feel that highly of me to bestow this award. It means the world to me."

The VGCSA held its 2020 Annual Meeting on November 17th in Zoom format. President Bill Keene opened the meeting and introduced the board members. He then thanked the corporate partners who supported the association in a difficult year. election results might affect VGCSA on the state and national levels.

Keene then presented a "Year in Review" presentation. Highlights included the trip to the General Assembly before COVID, the execution of ALL golf events, and the

Keene then delivered his remarks as parting President, thanking many people who helped them the past two years. Then he recognized incoming President Jeff Whitmire, who made



Secretary/Treasurer Mike Mueller gave the Treasurer's Report. The association remains in sound fiscal condition. Of the revenues, membership dues accounted for 18% of total revenue. This includes both state and local dues. The Partner Program, which was pretty flat in 2020, represented 35% of our total revenue, truly indicating the importance of industry support to our operation. Lane & Associates of Richmond is the association's accounting firm and they independently



review financial operations and prepare the tax statements.

Then Keene introduced Robb Bohannon of Hunton AK, the VGCSA lobbyist. Bohannon gave an overview of how successful pivot to accommodate COVID protocols, such as the partnership with the Carolinas GCSA to offer member education and CEU's. Also, the second edition of the BMP manual was completed. In addition, the Virginia Tech event was excellent, as was


the Assistants Forum.


BMP Second Edition Published



Government Relations Update

Capitol provides. The Pocahontas Building, where legislators' offices are located and where the public normally meets with lawmakers, will be closed to the public, and will only be open to legislators and staff.

House and Senate Republican leadership announced in November they would only agree to a 30-day legislative session in 2021, as the General Assembly spent much of 2020 in special session. In an odd-numbered year, the legislature would usually meet for 45 days. Republicans have the ability to insist on this change, as moving beyond the constitutionally mandated 30-day session requires a two-thirds vote in both chambers. The House and Senate have both voted to limit the number of bills each legislator can file in 2021, and the General Assembly will likely hold meetings on Saturdays and Sundays during the regular session. Democrats have also indicated that should they not complete the work they deem necessary during the regular session, Governor Ralph Northam (D) could call a special session to address unfinished business.

Committee chairs are expected to be judicious in determining which bills will be docketed for consideration, as there will less time for debate and discussion. Both agricultural committee chairs – Delegate Ken Plum (D-Fairfax) and Senator Chap Petersen (D-Fairfax City) – may have only a few meetings before the crossover deadline, whereby bills must pass their chamber of origin.

Prefiling of legislation has already begun, and VGCSA is actively monitoring these filings. A significant amount of time in December has been devoted to discussing priority issues with lawmakers, understanding that in-person access to legislators will be limited in 2021. We will continue to keep the membership apprised of any legislative concerns that arise, and work to address them as needed.

Jeff Snyder of Penhook, VA and The Water's Edge Country Club has been recognized by the VGCSA with the 2020 President's Award. The award is "in recognition of a career of distinguished and meritorious service and commitment to advancing the profession of golf

course superintendent in the Commonwealth of Virginia, and in the grateful appreciation for over twenty years of contributions that led to the advancement of association affairs since its inception." The award was presented by VGCSA President Bill Keene during the Annual Meeting.

Growing up, Snyder's dad John was the pro at Farmington Country Club, so a career in golf was in his blood. Basically he would take a bus to school and then a bus to Farmington, where he worked for his dad in many roles around the club. It was a family operation, and a great experience growing up.

As a HS Senior, he got a little frustrated with working in pro shop, so he went to work on the

golf course for Superintendent Dick Fisher. He would never forget riding around with "Fish". After high school, he headed off to college, and his buddy Steve Vessels convinced him to enter the turf program at NC State. He graduated in 1984 and went to work for Albemarle Farms, a 9-hole golf course in John Kluge's front yard. Right out of school he got that job to look after Mr. Kluge's varied forms of recreation, including a spectacular grass croquet court. It was a learning experience from the ground up, and he did everything.

He enjoyed the work at the Kluge estate, but he knew he needed a broader experience to advance his career. So in 1988 he left for southern Virginia to an 18-hole course, Skyland Lakes. He stayed there just a year and a half, then went to Louisa and got job at Shenandoah Crossing, a course he helped build. For five years he grew the club, then left there for The Water's Edge at Smith Mountain Lake in 1994, and last year celebrated 25 years. His dad had moved there from Farmington to open the course, and Jeff worked with him from 1994-98. His dad was the best advocate for superintendents.

Snyder describes TWE as among the most fun courses as you can play. "It touches the lake on three holes, and you're



feeling it on 10-11 others, it's there for you to enjoy. I enjoy coming to work every day," he said.

As a volunteer, Snyder got involved with the VTA while at TWE. At the time, the Old Dominion GCSA was only affiliated chapter when GCSAA required members to join a chapter. So in 1999, he was the rep of VTA when regional reps met in the basement of Keswick and brainstormed how to create an umbrella group to certify with GCSAA. Peter McDonough had a "road map" from a buddy in Florida, but they had no idea how long it would take to get there. Snyder went to GCSAA HQ in Kansas and the group got it done. He was among the first Presidents for VGCSA, serving 2003-05.

Afterwards he was always a resource to VTA, and this year he decided to jump back in and help VTA. He loves working with VTA President Brian Kearns of Primland, remarking, "You could hit him in the knee cap with a 9-iron and he would still smile!"

In receiving this recognition, he said, "Anytime you get something from peers, it's that much more special, no doubt! I wouldn't be here without them, Dick Fisher in particular. A lot of people could say the same thing. It's very humbling, and it couldn't be more special."

On a personal level, Jeff is proud of his daughter Cameron (20), who is working and getting ready to go to real estate school, as well as son Eric (27), who is a rescue swimmer for the US Navy.
