Each Lady will receive 80% of their Handicap and 10 Shot Differential is in Effect

1. Flights 1, 2 & 3- Copper Tees / Flight 4- Teal Tees

2. Please record scores on the official scorecard and attest after round

3. Flag locations are Red=Front, White=Middle, and Blue=Back

4. Today we will be playing "Lift, Clean, and Place" in the closely mowed areas (Fairway

& Fringe) If your ball lies in an area that is newly seeded or bare, please move no nearer to the hole and find a good area to play from. (No penalty) Flighted Situation Prizes:

Flights 1 & 2 Longest Drive- #10 Closest to the Pin-#7 Longest Putt Made-#2 Flights 3 & 4 Longest Drive- #6 Closest to the Pin-#16 Longest Putt Made-#11

- 4. If unsure on a rule. Please play a second ball and ask rule committee after round.
  - (USGA Rule 3-3)
- 5. Optional Drop areas located on #5, #6,#7, #14,#16
- 6. In the event of a tie, a USGA recommended scorecard playoff will occur.

All U.S.G.A Rules shall govern play. See other side for Local Rules

\*In the event of bad weather the tournament committee will blow the siren (3) times to clear the course. Once all is clear the tournament committee will blow the siren (1) time to resume play.

#### Notice to Players

Play is governed by The Rules of the United States Golf Association and this notice.

**ASSISTANCE**—Referees will be on the course. If one is not immediately available call the pro shop: 970.252.1119 extension 1. Additionally, you may play two balls. Procedure: Before taking further action the player should notify a fellow competitor and indicate which ball he wishes to count. There is no penalty if he doesn't. He must notify the committee before return his scorecard or he is disqualified.

**TOILETS**—Toilets are located at the clubhouse, near hole #6 tee, and past hole #12 green. Restroom Code is 2019

TIES— If there is a tie following 18 hole of competition, the tie will be broken by the recommended USGA Scorecard Playoff.

#### THE COURSE

# ROSEBUD TOURNAMENT DROP ZONE RULE: If a player is unable to navigate the penalty area on holes #5 & #7, a drop area is provided. A player must try to navigate the area twice. If they are on unable to get the ball in play, the player may use the drop zone. At this point, the player will be dropping in the drop zone and hitting their 5<sup>th</sup> shot.

**OUT OF BOUNDS:** Out of bounds is defined by a painted line or a line between the course-side points at ground level of: 1. Capped white stakes; 2. Fence posts (if gabions are present, use them); 3. Inside edges of city sidewalks. A ball is out of bounds if it comes to rest on or beyond East Oak Grove Road, even if it comes to rest on the other hole.

**IMMOVABLE OBSTRUCTIONS**—Concrete paths are immovable obstructions. All other paths are integral parts of the course. White lined areas that tie into an obstruction have the same status as the obstruction; that is, relief may be taken from both areas at the same time. Relief may be taken from immoveable obstructions close to putting greens. Use Rule 16.1 for the relief area.

**INTEGRAL PARTS OF THE COURSE**—The rock wall near the 18<sup>th</sup> green and rocks adjacent to it are integral parts of the course. That is, the player does not get free relief.

**IMMOVABLE OBSTRUCTIONS**—Concrete paths are immovable obstructions. All other paths are integral parts of the course. White lined areas that tie into an obstruction have the same status as the obstruction. That is, relief may be taken from both areas at the same time

**OUT OF BOUNDS NO PLAY ZONES:** Adjoining properties with homes are out of bounds and are no play zones. If a player's ball is in bounds and anything in the no play zone interferes with the player's stance or swing, the player must take free relief under local rule E-9.

**DROP ZONES:** If a ball is known or virtually certain to be in a <u>penalty area</u> on hole 6, 14, or 16, the player may take relief under <u>Rule</u> <u>17.1</u>, or as an additional option, <u>drop</u> a ball in the drop zone. The drop zones locations: on hole 6 forward and left of the ladies tee; on hole 14 to the right of the pond; on hole 16 near the cart path in front of forward tee.

**PRACTICE PUTTING GREEN**—The practice putting green near hole 1 is not a wrong putting green during the play of hole 1. **WRONG GREEN:** When playing holes 6 and 15 if a player's ball comes to rest on or his or her stance or swing interferes with the putting green of hole 7, or the forward putting green on hole 15 when the back putting green is in play, the player must take relief under Rule 13.1f. The putting green is also defined to include the fringe under local rule D-4.

**IMMOVEABLE OBSTRUCTION**—Concrete paths are immovable obstructions. All other paths are integral parts of the course. White lined areas that tie into an obstruction have the same status as the obstruction; that is, relief may be taken from both areas at the same time. Relief may be taken from immoveable obstructions close to putting greens. Use Rule 16.1 for the relief area.

#### RELIEF

**AERATION HOLES:** If a player's ball touches an aeration hole in the general area: The player may take relief under <u>Rule 16.1b</u>. If the dropped ball comes to rest in another aeration hole the player may take relief again from the where the ball first lay. Interference does not exist if the aeration hole only interferes with the player's stance. If the ball is in on the putting green the player may take relief under <u>Rule 16.1d</u>. Free relief on the putting green is not allowed from interference with the player's <u>line of play</u>.

**HOOF DAMAGE:** Damage that is clearly identifiable as having been caused by <u>animal</u> hoofs is <u>ground under repair</u>. Free relief is allowed anywhere except the green under <u>Rule 16.1</u>. On the green hoof damage may be repaired under Rule 13.1

**PROVISIONAL BALL MAY BE PLAYED ON HOLES 7,9 and 16:** If a player is unsure if his or her ball has cleared the penalty area, a provisional ball may be played only on holes 7,9 and 16 under local rule B-3. If the original ball is not found, the provisional ball is the ball in play.
