<u>Meeting Note:</u> No news <u>Update:</u> County refused petition to install lights. Heritage Harbour Master is discussing possibility of fronting cost to install lights.

3. Barrier gate response time

<u>Meeting Note:</u> Currently the satellite gates are monitored by the gatehouse. This is why we are seeing a slow response time. Effective in the new budget Envera will take over monitoring of gates. New contract to include 30 second response time.

4. Back gate receiver needs to be adjusted

<u>Meeting Note:</u> Gate Repair Company was out and determined that some cars need to get close to the bar to open the gate. Other cars open the gate at a normal distance from the bar. River Strand is investigating replacement options for the reader.

5. Why are the main swing gates always left open?

<u>Meeting Note:</u> The main swing gates have been down recently due to controller issues, as of the meeting the gates were operational. New controllers have been

ordered and should be installed early 2015. Any member who finds any gate non-operational is encouraged to contact the office to report the issue.
