Upon a motion made by Terry Lyons, seconded by Bob Walsh,

It was voted in motion #17-267: that the current board subgroup of Mike Fisher, Eddie Hicks, and Bob Walsh that works with the property management corporate staff enter into negotiation with regards to the purchase of new software for the club, motion carried with Terry Lyons, Mike Fisher, Eddie Hicks, Scott Hancock, Bob Walsh in favor, and Anita Tierney opposed. **Motion passed.**

## On matters relating to the employee holiday fund:

Upon a motion made by Scott Hancock, seconded by Anita Tierney (to allow for discussion),

It was voted in motion #17-268: to provide a contribution of \$10,000 to the employee holiday fund to come from the retained earnings of the club with ICON to match up to \$5000 of the contribution, motion failed with Scott Hancock in favor, and Terry Lyons, Eddie Hicks, Mike Fisher, Bob Walsh, and Anita Tierney opposed. **Motion failed.**
