We discussed fines for outstanding violations. General guidelines is that a first offense of a procedural rule would cause a \$50 fine, other violations to be decided on a case by case basis.

104 River Enclave – No ARC filed prior to starting pool. Motion – Failure to apply to Arc for pool project warrants a fine of \$50. Motion carried

123 Winding River , 110 Winding River , 7121 River Hammock 201- Motion made to fine each of these homeowners \$50 for lack of paperwork and \$150 for short term rental.

207, 404 No action based on response from homeowners.

7609 Heritage Grand parking cart in golf course area – Fine \$50 to 7609 Heritage Grand for personal golf cart parked in the golf course area.

Sam presented on rentals with over 100 listings on VRBO and AirBnB with less than 30 day rental offers. She has done an extraordinary job looking at web site rental advertisements and identifying actual owners who appear to be violating the 30 day minimum lease requirements.

Motion made to form a Subcommittee to look at the short term rental issue. Chaired by Sam Pearce;, Stanley, Paul, Linda agreed to participate. Sam's participation must be approved by the BOD because she is not a member of the Compliance Committee.

The next scheduled meeting of the RSCCC is scheduled for second Tuesday of August

There being no further business, the meeting was properly adjourned at 5:54 PM.
