#### **MINUTES**

#### I. Call to Order:

The meeting was called to order at 6:10 pm

- **E.** <u>Front door peephole-</u> After discussion it was decided the Board of Directors would, in the Association's next newsletter, refer residents to "Nextdoor" if they would like to obtain installation references from their neighbors. Any resident with intentions to have a peephole installed must submit the proper ARC Application.
- V. Owner Comments a request was made to explore installing bike racks in the unassigned closets on each floor of both buildings.
