TERMS OF MEMBERSHIP

- 1. **Membership Plan.** I acknowledge receipt of the Membership Plan and Rules and Regulations for Tarpon Cove Yacht & Racquet Club dated January 2007 (collectively "Membership Plan"). I agree to be bound by the terms and conditions of the Membership Plan as the same are amended from time to time. I understand that the Club may amend the Membership Plan at any time in its sole and absolute discretion, and any such amendment will be binding on me.
- 2. **Offer of Membership.** I understand that this application will not be acted upon unless fully completed, signed and accompanied by a check for the membership fee and required dues. Once acted upon, the Club may, at its discretion, make an offer of membership. I understand I am free to either accept or decline the Club's offer of membership.
- 3. **Membership.** If I am offered membership, I understand that a condition of my acceptance is an acknowledgement that:
- the membership is not an investment, nor does it confer on the member any equity or ownership interest or any other property interest in the Club or Club Facilities Membership does not give a member a vested or prescriptive right or easement to use the Club Facilities, but grants to the member a license to use the Club Facilities revocable with or without cause by the Club in its sole discretion. Members will not have any interest in the income of the Club and will not have the right to receive any of the Club's assets if the Club is dissolved.
- I would be granted a revocable privilege to charge merchandise, fees, charges and food and beverage purchases to a club account established in my name. I understand I would be required to pay my club account balance in full, by the due date indicated on the statement. A club account not paid within fifteen (15) days of the due date will be deemed delinquent and will accrue an administrative late fee and interest from the date of the statement in the amount determined by the Club which shall not exceed the highest rate permitted by law. In the event my club account is delinquent, the Club may take any action it deems appropriate, including without limitation, suspension or involuntary resignation of my membership and/or institution of legal action to collect the delinquent amount, interest, fees and costs. Suspension of membership for delinquent club accounts shall not require a hearing by the Club. In the event legal action is commenced, a member shall be liable for costs of collection, including without limitation, attorneys' fees and costs incurred by the Club; and I know that the use of the Club Facilities and any privilege or service incident to membership involves the risk of possible injury. I hereby accept any and all risk of injury to myself, my guests and family sustained while using the Club Facilities or involved in any event or activity incident to membership. In accepting the risk of injury, I understand that I am relieving the Club and those employed by or affiliated with the Club from any and all loss, cost, claims, injury, damage or liability sustained or incurred by me, my guests and family resulting from or arising out of any conduct or event connected with membership and use of any of the Club Facilities.
- 5. Transfer of Membership. If the Applicant owns a home within the Tarpon Cove, Tarpon Bay or Wiggins Bay residential communities, as defined by the Club (the "Home"), and is an active dues-paying member on the date of the sale of the Home, the Applicant may arrange for the Club to reissue their Club Amenities Membership to the purchaser of their home upon approval of the purchaser's Membership Application and payment of the transfer fee equal to twenty percent (20%) of the membership fee in effect for the Club Amenities Membership on the date of closing of the resale of the Home. The completed Membership Application and applicable fees must be submitted no less than ten (10) days prior to the date of closing of the resale of the Home.
- 6. **Verification of Application.** By signing this application, I authorize the disclosure and release of information to the Club for investigating my qualifications for membership and authorize those persons or entities listed herein to furnish to the Club, information requested by the Club, including my credit history.

To Whom It May Concern:

This letter will serve to clarify the process for transferring an active Club Amenities membership upon the sale of property in the communities of Tarpon Cove, Wiggins Bay or Tarpon Bay.

- 1. In order for an active membership to be considered transferrable, the owner (Seller) of the property in question must have paid the annual club dues and all outstanding balances on their Club account prior to the date of sale.
- 2. Prior to or no later than the date of closing, the Buyer is responsible for paying a transfer fee. The current transfer is \$5,000.00 plus 6% sales tax.
- 3. It is the sole responsibility of the Buyer to refund directly to the Seller an amount equal to the prorated annual dues (based on the date of closing through December 31st of the year in which the sale is executed).
