AMENDMENTS TO HOUSE BILL 1354
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 4, after “services;” insert “defining a certain term;”; and after line 10, insert:

“BY adding to
Article – Tax – General
Section 11-101(c-4)
Annotated Code of Maryland
(2016 Replacement Volume and 2019 Supplement)”.

AMENDMENT NO. 2

On page 1, after line 20, insert:

“(C-4) “NAICS” MEANS THE NORTH AMERICAN INDUSTRIAL CLASSIFICATION SYSTEM, UNITED STATES MANUAL, 2017 EDITION, PUBLISHED BY THE UNITED STATES OFFICE OF MANAGEMENT AND BUDGET.”.

On pages 2 and 3, strike in their entirety the lines beginning with line 22 on page 2 through line 9 on page 3, inclusive, and substitute:

(15) ART MOVING, CLEANING, OR STORAGE;
