Terms & Conditions

1. All membership programs are granted on an annual basis. Renewal of these programs is at the sole option of the Club. These memberships shall be limited in such number as the Club from time to time deems appropriate. Your Program is valid only for a 12-month term upon date of application. All members will be billed a nonrefundable annual fee payable in advance. All members will receive notice that membership renewal has been awarded subject to receipt of payment.
2. The Club will establish an annual fee in such amount as it deems appropriate. The annual fee shall be paid to the Club when submitting application. If the application is rejected, the fee will be refunded.
3. All members may play the course upon payment of the applicable greens and/or cart fee or other user fees each time he/she plays.
4. Guest privileges shall be set by the Club, and may vary from season to season or be withdrawn at the discretion of the Club.
5. All members shall respect and treat with dignity other members, guests and Club employees. In particular, members shall not engage in offensive, harassing or other inappropriate conduct. Such behavior is against the best interests of the Club and could result in disciplinary action, including suspension or revocation of membership.
6. Club facilities: Membership at The Eagles Golf Club does not give a member the unlimited right to use the Club's facilities at all times. The use of the Club's facilities, including the golf course, will be restricted at certain times during the year, for example during tournaments and special events. The Club management in its sole discretion, reserves the right to refuse use of the Club's facilities to any person.
7. Full Golf, Seasonal and Corporate Member privileges include complimentary practice privileges. These privileges will be restricted during outings and special events. These practice privileges are NOT transferable to other individuals, and club members may NOT provide practice balls to other individuals that are not participating in the membership programs at The Eagles Golf Club. Violation of this policy shall be a suspension/revocation of practice privileges without a refund.
