This Agreement for a Stonewall Golf Club Annual Golf Membership Package is between Stonewall Golf Club at Lake Manassas and the undersigned Annual Golf Membership Package Participant. Upon acceptance and approval of this application by Stonewall Golf Club of Lake Manassas, the following terms and conditions shall apply.

A. The Participant Understands and Agrees:

1. To the Rules and Regulations of Stonewall Golf Club now in force or in the future adopted by Stonewall Golf Club, including but not limited to: 1) Rules and Regulations with regard to hours of operation 2) use of equipment and facilities 3) personal conduct and attire. Stonewall Golf Club reserves the right to revoke or suspend your contract for violation of any Rule or Regulation of Stonewall Golf Club by you or your guests by way of nuisance, disturbance to other members or golfers using the golf course and facilities, disruptive behavior, any conduct that Stonewall Golf Club determines is prejudicial to the welfare, good order and character of Stonewall Golf Club or if Stonewall Golf Club determines that your actions may endanger yourself or other persons. If your contract is suspended or revoked there will be no refund of fees.

- 2. To pay the entire Golf Pass Package Fee set forth below. Other than in the event of permitted cancellation described below, Annual Golf Membership Package Participants shall not be relieved of the obligation to pay any balances in accordance with this Agreement, and no deduction or allowance from payment shall be made by reason of the absence or withdrawal of the Golf Membership Package Participant from Stonewall Golf Club or by reason of the Golf Membership Package Participant's failure to use Stonewall Golf Club facilities.
- 3. All monthly payment plan payments are due by the 1st of each month; a late fee of \$25.00 will be assessed for any monthly payment not received at Stonewall Golf Club by the deadline date. Non-payment will result in immediate suspension of the Participant's benefits under this contract.
- 4. All payments are Non-Refundable.
- 5. All Annual Golf Membership Packages are non-transferable without the prior written approval of Stonewall Golf Club and the payment of a transfer fee, which is subject to change from time to time at the discretion of Stonewall Golf Club management.
- 6. This Agreement does not grant any lifetime rights to the Golf Membership Package Participant. Stonewall Golf Club reserves the right to reject any application or to terminate the use of its facilities or any part thereof by Golf Membership Package Participants at any time, with or without cause, after giving (30) day notice, in which event pro- rated adjustments in the Annual Package Fee will be made.
- 7. This Agreement is assignable by Stonewall Golf Club.
- 8. THIS STONEWALL GOLF CLUB ANNUAL GOLF MEMBERSHIP PACKAGE IS GOOD FOR 365 DAYS AND COMMENCES THIS _______DAY OF_________, 2015.
- 9. Stonewall Golf Club is a daily fee course open to the public and tee times may not be available when requested, and that the Golf Course may be closed from time to time without notice for golf tournaments and golf course maintenance projects.
- 10. Stonewall Golf Club maintains a forty-eight (48) hour cancellation policy and Stonewall Golf Club reserves the right to charge Participants full green fees for all tee times not cancelled at least forty-eight (48) hours in advance.

In the event of a Golf Membership Package Participant's death or disability, said Participant or his estate may terminate his Contract by providing to Stonewall Golf Club objective evidence from a third party of such death or disability that is satisfactory to Stonewall Golf Club, in which case the Participant's liability for Fees shall terminate as of the date of such death or disability
