**Class D:** Commercial/Allied/Supplier

**Class E:** Educator

**Class F:** Golf course employee other than a Superintendent or Assistant Superintendent or in the field of growing large areas of turf

**Class S:** Student (must be enrolled in a program that is based around turf grass management)

**Class R:** Retired as a golf course superintendent
