Summary of Membership Classifications

The Club offers the following Membership Classifications, subject to the terms and conditions set forth herein and the Club's rules and regulations:

<u>Family Membership</u> A Family Membership entitles all persons in the family who are under 22 years of age and residing within the member's primary residence, access to the golf course every day of the week. The Family Membership may be purchased by installments with Electronic Funds Transfer (EFT) to the Club under the terms set forth herein.

<u>Individual Membership</u> An Individual Membership entitles an individual access to the golf course every day of the week. The Individual Membership may be purchased by installments with EFT to the Club under the terms set forth herein.

Corporate Membership A Corporate Membership may be purchased by a Business Entity and assigned to an individual. The assignee(s) is entitled to access the golf course every day of the week. The Corporate Member may change the assignee on each membership one time during the membership term. Corporate Members qualify for a 10% discount off the purchase of 5 or more Corporate Memberships and a 20% discount off the purchase of 10 or more Corporate Memberships. Corporate Members also are entitled to one business outing of 100 players or less between September 1 and May 1 within the term of their membership at a price of \$20 per player, cart inclusive.

<u>Weekday Individual Membership</u> A Weekday Individual Membership entitles an individual access to the golf course from Monday through Thursday of every week. Weekday Individual Members are required to pay the applicable green fee and cart fee (if a cart is desired) in order to access the golf course from Friday through Sunday.

Non-Resident Membership An individual with a verifiable residence at least 60 miles from the Club is eligible to purchase a Non-Resident Membership. A Non-Resident Member is entitled access to the golf course ever day of the week.

National Membership An Individual with a verifiable residence at least 140 miles from the Club is eligible to purchase a National Membership. A National Member is entitled access to the golf course twenty (20) times during the term of the membership. A complimentary golf cart is included. The National Membership is not assignable.

<u>Terms and Conditions of Membership</u> The Club's memberships are subject to the following terms and conditions:

Membership Term All memberships shall have a 365-day term. For example, if a membership is purchased on July 1, 2016, it expires on June 30, 2017.

Golf Course Access The Club may restrict member access to the Club to conduct golf tournaments, golf outings and/or special events or on holidays to allow Club employees time with their respective families. The Club also may close the golf course due to inclement weather or in order to perform maintenance and repairs at its sole discretion. Members should check the Club's calendar on its website (boilingspringsgolfclub.com) in order to assure the golf course is available for member play.

<u>Cart Privileges</u> Only members 16 years of age or older, with valid driver's licenses, will be eligible to use the Club's golf carts. The cart privileges provided members of the Club are subject to availability. The Club has a fleet of fifty (50) golf carts. There is no assurance or guarantee that a cart will be available every time a member visits the Club.

Member Cart Fees. Memberships are cart inclusive.

<u>No Outside Food or Beverage</u> Members are strictly prohibited from bringing outside food and/or beverages onto the Club's grounds. Violation of this rule will result in suspension or termination of the member's membership at the discretion of the Club.

<u>Dress Code</u> Proper golf attire is suggested. Persons on the Club's golf course or in its clubhouse shall wear a shirt and shoes at all times.

Member Code of Conduct All Club members shall exercise proper golf etiquette, obey all club rules and be respectful of the Club's employees, other members and guests at all times. Habitual violation and/or abuse of the Club's code of conduct shall be grounds for suspension and/or termination of member privileges at the Club's sole discretion.

<u>Electronic Funds Transfer (EFT)</u> If a member purchases a membership eligible for payment by EFT and elects to pay for his or her membership in this manner, the Club must receive the final installment and full payment for the membership on or before May 1 of the membership term. The Club will not take

installment payments by EFT from May 1 through August 31. If a member elects to pay by EFT, then a recommended payment schedule is the first day of every month from September 1 through May 1. Ex. An individual membership purchased by EFT on this schedule would require a monthly transfer of \$166.67 + tax for nine (9) periods. Members who elect to pay by EFT and subsequently terminate the EFT prior to full payment of the membership will be denied access to the Club until the membership is paid in full.
