2020 Walden Swim and Tennis Club Pool Fees

Walden residents in **good standing**
(all HOA dues have been paid)
may apply for a 2020 pool season household membership.
Non-Walden residents may also apply.

WCA Resident/Tenant Membership: \$370 per household
Non-Walden Membership: \$565 per household

New pool passes **will be issued**, please read the entire letter to ensure that you provide the correct information for your 2020 pool pass.

Household Definition: Only family members that **reside in the home 12 months a year** can be pool members. All others are considered guests. Proof of residency is required from **ALL** adults.

4 Adults (18 and Older) 4 Children (17 and Younger)

(Includes up to **8** members with a **MAXIMUM** of 4 Adults for an additional fee of \$60 per Adult)

- **Anyone over the age of 18 is required to submit a photo copy of a current Driver's License or Maryland ID with this application, please email them to Admin@waldencountryclub.com.**
If you were a member last year and nothing has changed no need to resend these documents.
- To guarantee your passes for Opening Day, you must have your **completed** application in by **April 27, 2020**. After that date spaces will be available but passes **MAY NOT** be completed.
- Email is important for application issues and upcoming events.
- **Please watch for your check to clear, this is the only membership confirmation you will receive.**
- There is a 2 week processing time.
- **Space is limited.** Completed applications are processed on a first come/first serve basis. **Incomplete applications will not be processed.** Walden Swim and Tennis Club reserves the right to establish a wait list.
- **One Babysitter, Nanny or Mother's Helper (Will Not need Copy of Photo ID)**

Can be added as an extended member to the current membership for an additional \$60 for the season

Do not mail photos with your application! Pictures will only be accepted via email.

Important Things to Know:

- **Children that are NOT potty trained may NOT swim in the adult pool.**
There will be **NO** swim diapers/pull ups in the adult pool. Pool closures resulting in "accidents" could result in a fine.
- U. S. Coast Guard approved Type 2 Puddle Jumpers will be permitted in the roped off section of the big pool. Please see Pool Rules for more information.
- Noodles or kick boards are permitted to be used by patrons who can swim on their own without a floatation device.
- Alcoholic Beverages not purchased from Walden Country Club are not permitted on the premises.
Violation of this rule could result in revocation of pool membership.
- There will be a \$25.00 Returned Check Fee for any Returned Checks.
- An email with important information will be sent to you closer to the Opening Day to confirm membership.
- Tennis memberships are included with the pool.

POOL PASSES:

New 2020 paid members will be issued one pass for each household member.

- ▶ **2018/2019 Members do not need to resubmit pictures!!!**
- ▶ A photo is required for each pass (please send as a JPEG)
 - Picture must be an unobstructed view of face.
 - Photos must be **labeled** or easily identified.
 - Photos must be emailed in a timely manner to admin@waldencountryclub.com
- ▶ If you would like to update a photo please send in ASAP
- ▶ An email will be sent inviting you to pick up passes at the **Walden Swim and Tennis Club Open House** on **Monday May 18, 2020 from 4pm to 8pm** which will be held at Walden Country Club.
- ▶ Passes will also be available at the front gate of the pool on Opening weekend and thereafter.
- ▶ Lost passes can be replaced at a cost of \$10 per pass. Contact admin@waldencountryclub.com for a replacement pass.

GUEST PASSES:

A 2020 Walden Swim & Tennis Club membership includes 3 guest passes. Lost guest pass **will not be replaced**.

- ▶ Additional guest passes will be available for purchase at the **Walden Swim & Tennis Club Open House** on **Monday May 18, 2020 from 4pm to 8pm** and Opening Weekend Saturday and Sunday from 12pm – 2pm. Additional passes will be issued at a cost of \$30 for 5 visits.
- ▶ Without a pre-purchased guest pass, guests may be brought to the pool at a cost of \$7/day.
- ▶ Guest Passes **EXPIRE** at the end of each season and are nonrefundable.

NO Pass = NO Entry = No Exceptions
