Walden residents in **good standing** (all HOA dues have been paid) may apply for a 2022 pool season household membership.

Non-Walden residents may also apply.

WCA Resident/Tenant Membership: \$400 per household Non-Walden Membership: \$595 per household

We will continue to use the digital PoolEntry pool pass system for the upcoming season. In terms of COVID-19, Walden Swim and Tennis will follow all regulations and rules from government agencies. As a result, rules and regulations are subject to change

**Household Definition:** Only family members that <u>reside in the home 12 months a year</u> can be pool members. All others are considered guests. Proof of residency is required from **ALL** adults.

Includes up to 8 members: 4 Adults (18 and Older) 4 Children (17 and Younger)

MAXIMUM of 4 Adults; More adults may be added for an additional fee of \$60 per Adult

- Anyone over the age of 18 is required to submit a photo copy of a current Driver's License or Maryland ID with this application, please email them to <a href="mailto:Admin@waldencountryclub.com">Admin@waldencountryclub.com</a>. If you were previously a member and nothing has changed, no need to resend these documents.
- To guarantee your passes for Opening Day (May 28,2022), you must have your completed application in by May 13, 2022. After that date spaces will be available, but passes MAY NOT be completed in time for opening day.
- Email is important for application issues and upcoming events.
- Please watch for your check to clear, this is the only membership confirmation you will receive.
- There is a 2-week processing time.
- Space is limited. Completed applications are processed on a first come/first serve basis. Incomplete applications will not be processed.
- One Babysitter, Nanny or Mother's Helper (Will Not need Copy of Photo ID) can be added as an extended member to the current membership for an additional \$60 for the season

#### **Important Things to Know:**

- Children that are NOT potty trained may NOT swim in the adult pool. There will be NO swim diapers/pull ups in the adult pool. Pool closures resulting in "accidents" will result in a fine.
- U. S. Coast Guard approved Type 2 Puddle Jumpers will be permitted in the big pool under certain restrictions. Please see Pool Rules for more information.
- Noodles or kick boards are permitted to be used by patrons who can swim on their own without a floatation device.
- All alcoholic beverages MUST be purchased from Walden Country Club. Outside alcoholic beverages are prohibited. **Violation of this rule could result in revocation of pool membership.**
- There will be a \$30.00 Returned Check Fee for any Returned Checks.
- Tennis memberships are included with the pool.
