Outing Terms & Conditions

1. All outings require a 10% non-refundable deposit and signed contract with Heron Lakes.
2. A guaranteed number of players must be confirmed, **in writing**, to Heron Lakes by no later than **10 days** prior to the scheduled date of play. For Shotgun Outings, a guaranteed number less than 60% of the originally contracted amount may result in alteration to Tee Time Outing (all Shotguns require a minimum of 40 players).
3. Billing for the guaranteed number of players will occur, even if they do not all play or eat.
4. A final players list must be provided to Heron Lakes no later than **72 hours** prior to the scheduled date of play.
5. Group is required to finalize all rules sheets and pairings sheets no later than **24 hours** prior to the scheduled date of play as no changes will be accepted after this time.
6. Any outside food and/or beverages must be approved by written permission of the Heron Lakes General Manager.
7. Group must play within USGA pace-of play guidelines set for each course.
8. Group will be responsible for all lost or damaged course property caused by any of the participants.
9. Outings will not be considered “booked” until a finalized contract with the correct, non-refundable deposit is returned to Heron Lakes. Upon such confirmation, the event will be considered confirmed and definite.
10. Full payment is required no later than on the day of the event unless prior written arrangements have been made with the Heron Lakes General Manager.

Alcohol & Behavior Policy

The City of Portland and Heron Lakes wants you and your participants to have fun and enjoy our golf course. While we realize that the consumption of alcoholic beverages may take place during your event, it is important to be aware that unruly or inappropriate situations resulting from excessive drinking will not be ignored. So stated, by signing this agreement, you agree to take responsibility for the behavior of the participants of your event. Any person(s) engaging in offensive or inappropriate behavior toward our staff or other patrons will be asked to leave the premises immediately.

Inclement Weather Policy

In accordance with the United States Golf Association, Rule 6-8, “Bad weather is not in and of itself a good reason for discontinuing play.” Dangerous weather may be a reason to temporarily suspend play; however, total cancellation for weather reasons will occur only if Heron Lakes deems the course to be unplayable and unlikely to return to a playable status in a reasonable time to complete the entire event. In the instance of an event being cancelled or rescheduled, the parties understand and agree that the food and beverage arrangements had they already been prepared will not be cancelled, or that any items ordered through Heron Lakes as tee gifts or prizes will apply regardless.

COVID-19 Rider

Due to possible restrictions on group gatherings in Oregon, your event is subject to agreements in addition to the event contract to ensure the safety of guests and staff, and to follow executive orders of state and local governments. As the host of an event at our facility, you recognize and agree to follow any such restrictions, limitations, and/or requirements that are in place on the day of your event – which could even require the event to be canceled on short notice. Such restrictions include, but are not limited to, group size limitations, contact tracing, limitations on food and beverage service, social distancing, and mask requirements. Heron Lakes will provide as much advance communication with you as possible should any such restrictions affect your event.

Outing Planning Guide & Checklist

Task / Procedure	Deadlines	Status
Choose potential event dates and contact Heron Lakes to begin booking process	6-12 months prior to event day	
Determine budget and decide on package options for golf, merchandise and food & beverage	6-12 months prior to event day	
Finalize contract and deposit with Heron Lakes to secure event date and outing package	6-12 months prior to event day	
Select hotel site and transportation needs	60-90 days prior to event day	
Place merchandise order with Heron Lakes (include logos for custom orders)	60-90 days prior to event day	
Determine the number of sponsorships and volunteers needed for the event	60 days prior to event day	
Decide on format, contest holes, rules, etc.	30-60 days prior to event day	
Finalize all food & beverage details including sides chosen and number of guests eating	30-60 days prior to event day	
Finalize your field of players	30 days prior to event day	
Notify Heron Lakes of final number of players	10-15 days prior to event day	
Submit final players list to Heron Lakes	72 hours prior to event day	
Approve final pairings list and rules sheet	24 hours prior to event day	
Submit event payment and begin rebooking process for next year's event with Heron Lakes	Day of event
