



## Golf Course Superintendent Plainview Country Club – Plainview, Nebraska

**Course:** Plainview Country Club is a semi-private, 9-hole golf course in northeast Nebraska along Highway 20. We are a fun, but challenging, 9-hole course with 5 sets of tees for the Championship golfer through beginning youth. There is a newer, computerized irrigation system. Our facilities include a clubhouse with a full bar, driving range, chipping and putting green, and camping sites in a park setting with a fishing pond. We are available for corporate outings, receptions, and large/small gatherings.

**Job Description:** Golf course superintendent will be responsible for operating the golf course, maintain the park area, and perform general maintenance. Responsibilities include turf grass / agronomy maintenance, equipment maintenance, personnel management of part-time summer help, maintaining irrigation systems, applying herbicide and pesticide, and complying with regulatory guidance. The Superintendent will report directly to the Board and work with the Clubhouse Manager to create a fun golfing and entertainment atmosphere.

### Basic Functions:

- Operate the golf course and park in a professional and financially fiscal manner.
- Work independently as a self-motivated problem solver.
- Responsible for all components of agronomy, mechanical maintenance, expense control, and personnel decisions.
- Collaborate with the Board regarding necessary golf course maintenance.
- Develop annual landscape plans and provide input on long-term strategic direction for the course grounds.
- Assist with administration and enforcement of Club rules, regulations, and policies.

### Primary Duties:

- Oversee the care and maintenance of the turf, plants, trees, shrubs, ponds, and waterway on the facility grounds.
- Administer application of chemicals (fertilizers and pesticides) and maintain recordkeeping of usage.
- Direct and/or Administer the planting of new vegetation and replacement of existing vegetation, including spraying, pruning, and trimming associated with landscaping.
- Manage the computerized and/or manual irrigation systems on the golf course and driving range.
- Oversee, supervise, hire, and train part-time employee staff regarding course maintenance, equipment, and safety of operations.
- Complete general equipment and irrigation maintenance and repair. Order parts and supplies, as needed, and obtain approval from the Board for significant equipment purchases.
- Schedule maintenance practices efficiently and effectively, working around member play, tournaments, and outings.
- Provide updates at monthly Board meetings.

### Minimum Qualifications & Compensation:

- Salary is based on experience. PCC provides a 1-bedroom house and utilities for living accommodations.
- Experience in Turf Management field (agronomy, plant science, soil science, or horticulture).
- Pesticide application license. Prefer Grade 5 water license, or willingness to complete certification.
- Valid driver's license.
