Another long winter season will be over soon. The last winter day at all three locations will be Friday April 14th. Play stops at 11 p.m. at the East, midnight at the North and South. We were very lucky to have very few shutdowns this winter due to bad weather. We hope you've had a great season and are looking forward to the next season.

Your 2023/24 membership is now available. You can register only online through the website. Your early bird renewal rate is \$295 plus tax. The late renewal rate after June 1st is \$310 plus tax. Renewing membership fee has increased by \$15 from the previous year.

You must rejoin before June 1st to get into the PCT draw for next season. In an effort to help members improve their chances of getting court time through the lottery we will reduce the total number of adults we take into membership.

PLEASE NOTE: WE HAVE OVER 1000 NAMES WAITING TO JOIN. IF YOU DO NOT RENEW BY JUNE 1ST, YOU MAY NOT GET IN FOR NEXT WINTER. DO NOT DELAY.

PCT APPLICATIONS now available [Click Here](#)

PCT Application forms can be found at all three sites up until Friday April 14th. After this date they will only be available online or at the North Bubble. Applications can also be handed in at all 3 sites up until April 14th, after this date applications must be handed in to the North Bubble or sent in the mail. To print a PCT form and mail in [Click here](#). One PCT Application form per group only please. All players must be paid members to apply for PCT. Applications must be received by June 1st.

Members who are able to book daytime PCT are encouraged to do so. Your consideration of these daytime hours will help free up court time during prime time hours for the benefit of all members unable to book non-prime hours. It is also a great way to save a few dollars.

There will be no 2-hour singles bookings, casual courts or PCT, Monday to Friday, 6pm, 7pm, 8pm or 9pm.



Food for thought PCT Savings: Members who have the ability to play weekdays instead of evenings should consider this as a great way to save. EXAMPLE: The cost of a 2 hour booking from 7- 9 pm on a weekday evening for 25 weeks is \$1260 plus HST whereas a 1-3 pm booking on the same day for the same 25 weeks would only be \$1110 plus HST for total savings of \$150 plus HST.

No PCT Premium for any PCT Monday to Friday 7am or 8am or any evening at 11pm

Remember that any Permanent Court Time booked as a singles court will only be allowed to be played as singles. If you wish to play doubles two guest fees will be charged to the names on the PCT booking, whether the players are members or not. Once the PCT court is booked as singles it will not be changed to doubles.

Summer Courts

The North bubble will remain open all year. Members who are active in the system will be able to:

1. Place lottery requests (8-14 days in advance)
2. Book casually online. (7days in advance)
3. Inactive and non-members can book 5 days in advance.
4. The cost is \$15 including HST to be paid at the time of play.
