GOLF RULES AND REGULATIONS

1. U.S.G.A. Rules govern all play at the Club, except when modified by local rules which are printed on the back of each score card.
2. Slow play cannot be tolerated.
 - a. Starting times places groups one shot behind the group ahead and this distance will be maintained for completion of round.
3. Golf carts must be used on the golf course and under the following conditions:
 - a. Only two persons may ride at one time.
 - b. Based on weather conditions, carts must follow the daily cart driving rules.
 - c. Only persons with a valid driver's license will be permitted to operate golf carts.
 - d. Walking – no cart used – is only permitted after 3:30pm.
 - e. Cart use is suspended only if caddie is used.
4. Practicing is not permitted on course. Players are not allowed to play more than one ball.
5. All ball marks must be repaired and divots must be replaced. A mixture of seed and topsoil is provided on each cart. Please use it to replace your divots.
6. Players having holed out shall immediately leave the green. Do not practice when others are waiting. Wait until you get to the next tee to write in the score.
7. Players cutting from one hole to another have no standing on the course.
8. Procedures for dealing with violations of the course:
 - a. 1st offense will be a verbal warning from the ranger with the offender's name given to the manager.
 - b. 2nd offense will result in a letter from the manager with a copy posted on the bulletin board.
 - c. 3rd offense will result in loss of playing privileges during prime time for 2 weeks.
 - d. 4th offense will result in loss of playing privileges during prime time for balance of season.
9. We have no authority to waive, cancel or adjust any charges for green fees, cart rentals, membership dues, lockers or handicap fees.
10. Soft spikes are mandatory for all members and guests at the Knoll West Country Club.
11. Personal checks will be accepted from members in good standing only, and only for the amount due for golf. **NO CHANGE WILL BE GIVEN BACK.** Third party checks cannot and will not be accepted under any circumstances.
