2021 Corporate Membership

Corporate Membership

Each designee is entitled to the use of all club facilities.

- \$3,500 (plus sales tax), one-time nonrefundable initiation fee.
- Corporation must have at least (3) three designees to be eligible for this membership category
- \$25 application fee is required for credit report and processing per corporate designee.
- \$386.25 (plus sales tax) Monthly dues per corporate designee
- \$180 (plus sales tax) Quarterly food and beverage minimum per corporate designee.
- Each designee is responsible for the payment of RCC monthly statements. The Corporation guarantees payment of all designees.
- Corporation may change any of the named corporate designees to a different name designee upon the payment of a \$100 processing fee
- Corporate Memberships may only be transferred to Regular Resident Membership status as follows:
 - A. A corporation may release any and all memberships but must have (3) three active designees. Corporation may release or change designees at any time by informing RCC. Any released designee may revert to an individual membership with full voting privileges.
 - B. If the corporation wishes to drop its Corporate Membership, any individuals with a designated corporate membership may transfer to an individual membership as provided above.
- Each Corporate Membership shall have one designated person with one vote.
- \$100 quarterly Capital Reserve Program Fee (CRPF) will apply for each designee
