Authorization for Payment of Dues – Electronic Bank Draft

I authorize GreatLife Golf & Fitness and the financial institution named on the attached check or deposit slip to deduct, the amount of my monthly dues & any charges made to my membership account, from the account identified on the attached check or deposit slip. I understand my automatic payment will be deducted on the **15th date of each month. If the 15th falls on a weekend or bank holiday, the deduction will be drafted on the next business day following the 15th.** Changes in account or bank information must be submitted in writing to the course in which the member belongs. Changes must be received prior to the 1st business day of any given month in order to be processed for that month's payment. Cancelling a bank draft does not cancel a membership or cancel charges accrued on the membership account. In the event that a bank draft is revoked or an account is closed & new bank information is not received, the membership will be automatically transferred to the "annual payment" option & the remaining amount due under the terms of the Contract will be owed. Early termination (prior to April 1 of any given year) will only be accepted in the event of a member who passes away or a member who has accepted military assignment out of the area for more than 30 days.

A \$30.00 return fee will be charged for each returned bank draft.

Membership may be cancelled by sending written notification the respective GreatLife Golf & Fitness course & will be honored under the terms outlined in the General Information & Procedures Document (Addendum B). The fiscal year runs from April 1 of any given year to March 31 of the following year. The membership is for a (1) year period & automatically renews for another one year period on April 1 of each year unless written notification is received by February 28th of the year in which the member wants to cancel. Your authority will remain in full force & effect until written notification is received by the respective GreatLife Golf & Fitness course.
