# **2022 Operating Budget Notes**

The Place Master Association 2022 Budget has a slight increase from 2022.

The following table shows the cost comparison amount per home per month between 2021 and 2022 the proposed budget.

Lot Width	2021	2022
52's	\$311.89	\$329.02
62's	\$321.89	\$339.02
75's	\$331.89	\$349.02

The increase on average is 5.37% or approximately \$17.13 per home per month and is based on the following breakdown:

\$7 increase per home per month is a combination of common area landscaping, common area landscaping extras, common area tree trimming, sedge treatment, single family home landscaping, and lake maintenance.

\$5 increase per home per month relates to a contract with the gate company for gatehouse employees and gatehouse staffing

\$3 increase per home per month relates to staffing

\$2 increase per home per month relates admin related expenses including additional use of paper products in office supplies and increased IT security and IT Services
