The meeting was brought to order at 6:00 pm

New Business: Stuart Smart announced that the Employee Retention Credit for quarters two, three, and four of 2020, had finally been processed, and checks totaling \$54,717.35 had been deposited into the savings account.

Meeting Minutes: Guy Weishaar moved to approve the February meeting minutes. Julie Hickerson seconded the motion. All were in favor. The February minutes were approved.

Old Business:

- Handicap Access
 - Ron Arritola and Tiffany Sherman looked into handicap access again.
 - Handicap access is not workable unless the area is completely remodeled.
 - o LGCC currently meets ADA standards.
 - Guy Weisharr moved to remove the issue from the table indefinitely. Tiffany Sherman seconded the motion. All were in favor. The issue will be removed from the agenda and no longer be discussed.
- Cart Shed Numbers: Completed
- Annual Meeting and Voting Procedures:
 - Steve and Peggy Anthony are the non-board members on the nominating committee, and Ron Arritola and Julie Hickerson.
 - The Annual Meeting will be held on Wednesday, April 27th at 6:00 pm.
- Lower Clubhouse Flooring:
 - The flooring has been rescheduled to May 2^{nd} due to the material not arriving on time.
 - The baseboards that have been removed will be touched up or painted and replaced once the flooring is installed.
- Window Treatments in Upper Clubhouse:
 - Ron Arritola brought in a sample and acquired two bids.
 - Although the sample was satisfactory to block light, there was already a complaint from a member regarding not liking them.
 - The quotes were approximately \$2,500.
 - Julie Hickerson moved to remove the purchase and installation of new window treatments from the agenda and not proceed with the project at this time.
- The parking lot repair and sealant is a more pressing matter.
 - Ron Arritola will look into getting bids on the resurfacing/repairing of the parking lot.

New Business:

• Dwayne craft is removing and repairing the concrete outside of the golf shop/lower clubhouse due to the safety issue and repairing concrete on bridges #6 and #8.

Finance Committee:

• Finances look great, with the current bank balance at just over \$335 thousand.

 - Clearing drain on #2 green
 - Raking perimeter

 - Small tractors, loaders, and dump trailers would be helpful.
- No new updates on the mowers.
- May need to replace gutters on the west side of the cart barn will look at repairing first.
- Need to make a plan to clean out/up creek/slew of cattails and wild iris, and get it manageable.
- Brent and his crew have been working on getting rid of hazardous trees.

House/Social Committee:

- Penny Daniels was hired as the new LGCC Housekeeper.
- The house committee did a walkthrough on March 2^{nd} .
 - Item completed already:
 - Scrubbing doors and walls
 - Reupholstered upper clubhouse benches
 - Painted chairs yellow outside of the golf shop
 - Replaced broken bathroom fan
 - Updated ladies bulletin board area, and replaced table
 - In the process of updating the audio system
 - Items to be completed:
 - Spackle and paint touchups in the golf shop and stairwell
 - Change laminate on corner table
 - Paint flag pole
 - Acoustics in the upper and lower clubhouses need to be addressed.
 - Ron Arritola will look into solutions.

Membership Committee:

- Need to continue to promote junior golf activities to entice families to join.
