Membership -

- Family Membership: \$2,472 per calendar year or \$206 per month
- Additional Family Member: \$200 per year for 1st-\$100 per year for each Additional family member *Restrictions apply*
- Single Membership: \$2,124 per calendar year or \$177 per month
- Business Membership: \$6,490 per calendar year
- Executive Family Membership: \$2,124 per calendar year or \$177 per month *Restrictions apply*
- Executive Single Membership: \$1,764 per calendar year or \$147 per month *Restrictions apply*
- College Membership: \$413 per calendar year *Restrictions apply*
- Junior Membership: \$177 per calendar year *Restrictions apply*
- Basic Social Membership: \$142 for the calendar year
- Executive Social Membership: \$295 for the calendar year
- Founding Senior Membership: \$1800 per calendar year or \$150 per month *Restrictions apply*
- Founding Weekday Membership: \$1800 per calendar year -\$150 per month *Restrictions apply*

Range Passes – *Good for one year beginning at date of purchase*

- Single Range Pass – Member: \$200
- Family Range Pass - Member: \$250
- Single Range Pass – Non-Member: \$250

Membership Definitions and Restrictions

Family Membership-

Includes member, member spouse and children. Eligible children are defined as under age 18, or under age 25 and enrolled in school full time (defined as 12 state credits). Children may turn 18/25 during membership year.

Additional Family Member-

Allows members to add an adult child to their membership, defined as under age 28 and not attending full time school (defined as 12 state credits)

***Restrictions-** Additional family members must be the child, or child's spouse of a current member in good standing. Child/child's spouse may turn 28 during membership year. Upon turning 28, additional family members are not eligible for auto renewal. To maintain membership, a new membership application will be required.

Single Membership-

Member privileges for one member only. Does not include privileges for friends, or family.

Business Membership-

Open to any corporation/LLC. Good for up to four rounds and two carts per day. Not to exceed 20 rounds per individual per calendar year.

Executive Family Membership-

Includes member, member spouse and children. Eligible children are defined as under age 18, or under age 25 and enrolled in school full time (defined as 12 state credits). Children may turn 18/25 during membership year.

***Restrictions-** Available to member/member's spouse aged 35 and under. Member/spouse may turn 36 during membership year. Upon member/spouse turning 36, membership will auto renew to a 'Family Membership'.

Executive Single Membership-

Member privileges for one member only. Does not include privileges for friends, or family.

***Restrictions-** Available to members aged 35 and under. Upon member turning 36, membership will auto renew to a 'Single Membership'.

College Membership-

Member privileges for one member only. Does not include privileges for friends, family, or charging privileges.

***Restrictions-** Member must be under age 25 and enrolled in school full time (defined as 12 state credits). Member may turn 25 during membership year. Upon turning 25, membership will not auto renew. To maintain membership, a new membership application is required.

Junior Membership-

Member privileges for one member only. Does not include family, friend, or charging privileges.

***Restrictions-** Junior members must be aged under 18. Member may turn 18 during membership year. Upon turning 18, membership will not auto renew. To maintain membership, a new membership application is required.

Basic Social Membership-

Includes monthly newsletter and three rounds of golf per calendar year.

Executive Social Membership-

Includes monthly newsletter and six rounds of golf per calendar year.

Founding Senior Membership-

Includes member, member spouse and children. Eligible children are defined as under age 18, or under age 25 and enrolled in school full time (defined as 12 state credits). Children may turn 18/25 during membership year.

***Restrictions-** Member must be an existing *'Founding Member'* aged 70 or older and on a fixed income. Documentation of age and/or income may be required.

Founding Weekday Membership-

Includes member, member spouse and children. Eligible children are defined as under age 18, or under age 25 and enrolled in school full time (defined as 12 state credits). Children may turn 18/25 during membership year.

***Restrictions-** Member must be an existing *'Founding Member'*. Golfing privileges are restricted to play on Monday through Friday only. Any weekend (Saturday/Sunday) play must be purchased at current public greens fees.

Existing Founding Members-

This membership addresses those members who were part owners of the course when it was a private entity.

These memberships are grandfathered in at the current *'Executive Family Membership'* rate and are subject to any rate increases affecting this membership class.

This membership includes all privileges listed under *'Family Membership'*.
