- 1. ALL STARTING TIMES ARE TENTATIVE UNTIL SIGNED AGREEMENT AND DEPOSITS ARE RECEIVED BY THE E. GAYNOR BRENNAN GOLF COURSE.**
  - 2. THE TOURNAMENT DIRECTOR (*NAMED ABOVE*) WILL BE RESPONSIBLE FOR THE GUARANTEED NUMBER OF PLAYERS, DEPOSITS AND FINAL TOTAL FEES IN EFFECT ON *THE DAY OF THE TOURNAMENT.***
  - 3. FAILURE TO PAY FEES AND DEPOSITS ON A TIMELY BASIS WILL RESULT IN FORFEITURE OF ALL STARTING TIMES.**

THE E. GAYNOR BRENNAN GOLF COURSE RESERVES THE RIGHT TO CANCEL THE TOURNAMENT WITHIN **THIRTY (30) DAYS NOTICE**. CANCELLATION ON THE PART OF THE TOURNAMENT DIRECTOR **MUST** BE MADE **THIRTY (30) DAYS PRIOR TO THE TOURNAMENT DATE**. THE TOURNAMENT DIRECTOR WILL THEN BE REFUNDED ONE HALF OF HIS ORIGINAL (\$1000) DEPOSIT, \$500.00. **CANCELLATION OF THE TOURNAMENT LESS THAN 30 DAYS OF THE TOURNAMENT DATE WILL RESULT IN THE FORFEITURE OF THE FULL \$1000.00 DEPOSIT.** DEPOSIT REQUIRED: \$1000.00 PER TOURNAMENT WHEN THE SIGNED AGREEMENT IS RECEIVED. - 2. YOU WILL DECLARE THE FINAL NUMBER OF PLAYERS AND WILL PAY THE TOURNAMENT FEES IN FULL ON OR BEFORE THE TOURNAMENT DATE FOR FINAL NUMBER OF PARTICIPANTS. YOUR DEPOSIT WILL BE APPLIED TOWARDS YOUR TOTAL FEES PAYMENT DUE.**

November 30, 2020

1. ALL REQUESTS FOR GOLF TOURNAMENTS MUST BE SUBMITTED IN WRITING ON THE E. GAYNOR BRENNAN "TOURNAMENT AGREEMENT/APPLICATION FORM."
2. TOURNAMENTS MUST HAVE AT LEAST 60 PLAYERS FOR THE MORNING AND 80 PLAYERS FOR THE AFTERNOON. TOURNAMENT ADMINISTRATOR IS RESPONSIBLE FOR FEES FOR THE MINIMUM FOR YOUR STARTING TIME (60 AM OR 80 PM). MORNING SHOTGUN STARTING TIME WILL BE NO LATER THAN 8 A.M. AFTERNOON SHOTGUN STARTS WILL BE **APPROXIMATELY** 1:00 P.M.
3. ALL TOURNAMENT REQUESTS MUST BE APPROVED BY THE GOLF COMMISSION.
4. THERE WILL BE NO WAIVING OF GREEN FEES.
5. TOTAL TOURNAMENT FEE PER PERSON IS \$49.00. FEE SUBJECT TO CHANGE. TOURNAMENTS ARE RESPONSIBLE FOR THE FEE IN EFFECT ON THE DAY OF THEIR TOURNAMENT.
6. **DEPOSIT:** A DEPOSIT OF \$1000.00 WILL BE REQUIRED FOR ALL TOURNAMENTS. A TOURNAMENT WILL NOT BE CONSIDERED RESERVED UNTIL THE TOURNAMENT AGREEMENT IS SIGNED, A DEPOSIT OF \$1000.00 IS PRESENTED, AND APPROVED BY THE GOLF COMMISSION.
7. THE NUMBER OF PARTICIPANTS **MUST BE DECLARED IN WRITING SEVEN (7) DAYS PRIOR TO THE TOURNAMENT DATE.** SUCH DECLARATION MUST BE A MINIMUM OF SIXTY(60) FOR AM AND EIGHTY (80) PLAYERS FOR PM.
8. IN THE EVENT OF INCLEMENT WEATHER, THE DECISION OF THE GOLF COURSE REGARDING PLAY WILL BE FINAL. RAIN DATES ARE **NOT** GUARANTEED. IN THE EVENT THAT PLAY IS NOT ALLOWED DUE TO INCLEMENT WEATHER, ANY OPEN DATES WILL BE OFFERED. IF THE OPEN DATES ARE NOT AGREEABLE BETWEEN THE TOURNAMENT DIRECTOR AND MANAGEMENT, ALL DEPOSITS WILL BE REFUNDED AND THE TOURNAMENT WILL BE CANCELLED.
9. PROPER ATTIRE, PROPER EQUIPMENT AND PROPER CONDUCT WILL BE IN ACCORDANCE WITH THE **RULES & REGULATIONS** SET FORTH BY THE E. GAYNOR BRENNAN COURSE AND **APPLIES TO ALL PARTICIPANTS. ANY DAMAGES ARE THE RESPONSIBILITY OF THE TOURNAMENT DIRECTOR.**
