## **GOLF CART RULES AND REGULATIONS**

### **RIVER STRAND AT HERITAGE HARBOUR COMMUNITY ASSOCIATION**

**September 12, 2018**

- All golf carts MUST be registered with the River Strand Golf and Country Club, 7155 Grand Estuary Trail, Bradenton FL 34212. All golf carts MUST bear a community registration sticker. Sticker must be affixed conspicuously on both sides of the cart.
- Operational headlamps and tail lights are required for night time use. Carts without lights are not allowed to operate after sunset. Side mirror and windshield are suggested and additional safety items. Gasoline powered carts must have a muffler/silencer in place, and shall not emit excessive noise or smoke. Golf carts may NOT carry more than the number of passengers for which they were designed.
- Owners are responsible for any personal injury or property damaged caused by golf cart operation. The community assumes no liability for accidents, misuse, theft, damage, injury, or any other mishap arising from golf cart operation in the community.
- Golf carts may NOT be operated by unlicensed drivers, unless accompanied by a parent or guardian. (Parent or guardian MUST be in the front seat next to the operator). Persons under the age of fourteen (14) years of age shall NOT operate a golf cart at any time in the community. Operators MUST observe safe driving practices. Avoid excessive speed and unsafe maneuvers.
- Golf cart operation is limited to use on established community roads only. Drive in designated areas and obey all posted signs.
- Golf carts must NOT be parked in a manner, which interferes with vehicle or pedestrian traffic.
- Golf carts are authorized at any time.
- Open display or use of alcohol on golf carts is not allowed.

Non-Compliance with Published Rules will result in the Suspension of Golf Cart Privileges.
